Position Summary

Responsible for providing training, assistance and support to individuals receiving services in vocational and community settings, as well as through in-home services.

Essential Functions:

- Provide information to assist the individual program planning team to establish services, goals and objectives to meet each Participant's needs and personal goals.
- Provide on-going support and assistance to Participants in vocational and community settings, as well as inhome services as determined by the Individual Program Plan.
- Maintain standards of safety for Participants while participating in the program.
- Assist with mobility of participants including loading/unloading wheelchairs in vehicles and operating lifts to aid in the transfer of individuals.
- Provide Participant transportation as assigned.
- Project a positive image of the organization and persons with disabilities in the community.
- Quality control of contract work and assuring contract completion (may involve lifting of up to 50 lbs.).
- Maintain all needed documentation and records including Therap (electronic case management system) within required periods.
- Complete other duties as assigned.

Competencies

- Active Listening Ability to actively attend to, convey and understand comments and questions of others.
- Communication -- Ability to communicate effectively using both oral and written skills. Decision-making –
- Decision Making -- Ability to make decisions using personal judgment and creative thinking.

- Must be at least 18 years of age.

Skills and Experience:

- Ability to speak and read Basic English and comprehend complex instructions and short correspondence.
- Ability to load/unload wheelchairs from accessible vehicles, transfer individuals from a wheelchair to stationary chair, and assist in personal needs.
- Ability to work with individuals who have learning, comprehension, communication, emotional, as well as
 physical or mobility limitation; and who may have behavior issues.
- Ability to work in a wide variety of industrial or employment situations to assist in the training of individuals, to
 include performing physical demands or duties at that site.
- Ability to use Microsoft Office programs to complete required documentation.
- Ability with and knowledge of safe forklift operation. Forklift training and certification will be provided, as needed.

Requirements

- Must pass a drug test.
- Physical requirements include standing while working, moderate walking and the ability to lift 50 pounds.
